General Conditions:

- 1. Candidates passed in the grading system must possess at least a CGPA 3.00 on a scale of 5.0 and a CGPA 2.5 on a scale of 4.0 and passed in the conventional system (class/division) must possess at least 2nd class/division. Candidate having third Division/Class at any stage of academic career shall not be eligible.
- 2. Must demonstrate strong participatory leadership ability.
- 3. Able to demonstrate knowledge in Company Law, TQM, Corporate Governance and Strategic Management will get preference.
- 4. Must have strong communication skill in Bangla & English (written & verbal) and computer literacy.
- 5. Incorrect/incomplete applications and applications received after deadline will not be entertained and such applications will be liable for rejection at any stage of recruitment process.
